#### Section 6 - Special Displays

- 2. Displays may be entered in either operating or static class, not both.
- 3. Displays must be set up by 7 pm on Saturday, August 2 and remain on display until 8 p.m. on Saturday, August 9.
- 4. Incorporate primarily antique (50 years or older) items and only minimal modern/reproduction items to help share the display's story.
- 5. Larger than 50 sq. ft. or needing indoor display area must be approved by department staff.
- 6. Items eligible for judging in other sections in this department may be individually entered in those classes, however, they will remain on exhibit with the special display.
- 7. Operating class entries should be operated during at least 3 days of the fair. Static displays are not expected to operate.
